**FEGC submitted notification on reorganization to United State Registrar**

JSC RusHydro (ticker symbol: MOEX, LSE: HYDR; OTCQX: RSHYY) informs that on May 13, 2015, the Board of Directors of JSC Far Eastern Energy Company (FEEC), acting in capacity of the Extraordinary General Meeting of Shareholders of JSC Far Eastern Generating Company (FEGC) made decision to spin-off of Joint-Stock Company Luchegorsky Coal Mine (JSC LUR) from FEGC. On May 15th mandatory filing on the spin-off was made with the Unified State Registrar (EGRUL). On May 20th respective entry was made in the United State Registrar.

*JSC Far Eastern Energy Company is subsidiary of JSC RAO Energy System of East (a subsidiary of JSC RusHydro).*

*JSC Far Eastern Generating Company is 100% subsidiary of JSC Far Eastern Generating Company.*

*Luchegorsky Coal Strip is providing brown coal to Primorskaya HPP owned by FEGC.*

RusHydro Group is one of Russia's largest generating companies. RusHydro is the leading producer of renewable energy in Russia with over 70 generating facilities in Russia and abroad. The company also manages a number of R&D, engineering and electricity retail companies. Group's thermal assets are operated by subsidiary – RAO Energy System of East in the Far East of Russia. Total electricity generation capacity of the Group is 37.5 GW, heat capacity – 16.2 thousand GCal/h.

Russian Federation owns 66.8% in RusHydro, the rest is held by other institutional and individual shareholders (over 360,000). The company's stock is traded on the MICEX and RTS stock exchanges, and included in MSCI EM и MSCI Russia indexes. Company's GDRs in the IOB section of LSE, ADRs – in OTCQX.
