## RusHydro paid coupons on series BO-P01 bonds

**PJSC RusHydro** (ticker symbol: MOEX, LSE: HYDR; OTCQX: RSHYY) has paid coupons on series BO-P01 bonds (securities issue identification number 4B02-01-55038-E-001P of July 3, 2015).

1. Type, category (class), series, and other identification attributes of the issuer's securities upon which the yield was accrued: ***certificated interest-bearing nonconvertible exchange-traded bearer bonds with mandatory centralized custody, series BO-P01, placed through open subscription under the Exchange-Traded Bonds Program, identification number 4-55038-E-001P-02E of April 9, 2015, assigned by Moscow Exchange, ISIN – RU000A0JVLE0 (the "Exchange-Traded Bonds")***.
